She also addressed idea of self insurance, which she feels is not a good idea. Discussion followed. Motion by Steve, second by Per, to keep insurance as is. Motion passed 11-0.

- Cheryl reports that Village programs are encroaching on GMDBC times on Sumter, and points out we cooperate well and would like to get our old times back.
- Steve suggests the club establish a safety form to be completed after any boat accident. Board thought this was a good suggestion. Lee added that teams need to get the "boat bumpers" out before docking.
- John gave RaeAnn's treasurer's report, which is attached.
- Steve reported that a teammate brought up the idea of an AED available at both lakes. Waterfront Inn refused to discuss the issue. After much discussion, no decision was reached.
- Silver Dragons donated \$1325 to Honor Flight today, proceeds from their recent trivia night fund raiser.
- Cheryl brought up insurance waivers, with the company revising their form in mid January, after GMDBC signed electronic forms.
