# **Boat Maintenance and / or Lake Matters:**

- 1. John Townlet advised that all covers have now been ordered and are in process of being made. The new covers are all double stitched for extra strength.
- 2. Julie Coleman advised that all cages to secure the boat covers over are done.
- 3. The grass collecting by the boat launch area is creating a problem in getting the boats in and out of the water. The area needs to be cleaned. Cheryl Moran will find out what can be done to ease the issue of boats getting stuck in sand and the grass.

## **Old Business:**

Mary DeFranco reported the Sales Dept.'s Team Building paddle was a great success. After the Sales Dept. finished with a 3-boat race, they invited the volunteers to join them in their after party at The Waterfront Inn. This was very generous of the Sales Dept. Everyone had a wonderful time.

The sales dept. had 30 participants signed up and 19 showed.
