Opening:

Cheryl Moran called the meeting to order at 1:00pm.

Secretary Report:

Motion to approve as posted was made by John Townley and 2nd. by Julie Coleman. Motion approved.

Elly Olesen reported on the nominations for President and Secretary.

The missing AED will be replaced and an air tag for tracking will be placed somewhere in the AED. Mary DeFranco will order the AED. The cost of \$1,741.00 was approved at an earlier meeting.

Boat Maintenance and/or Lake Matter:

The storage boxes at Lake Miona and Lake Sumter needs to be replaced with stronger and bigger boxes.

A box like the Kayaks box. Steve Augustine has worked very hard on this project and also to get discounts by buying two boxes. \$1.241.00 each and free shipping. Motion was made by Mary DeFranco to buy 2 boxes. 1 for Miona and 1 for Sumter. This was 2nd by Shelby Imus, motion approved.

Captains and steers were requested to keep the boats 100 yards from the fishing boat on Lake Sumter.

When white caps are on the Lakes, the boats are not allowed out.

Ray Vail asked if anything would be done about the grass closing in on Lake Sumter. Cheryl Moran responded: Not at this time per EPA regulations.

Old Business:

Picnic report: Reported by Mary DeFranco under Vice President Report.

Pool Safety Report: Julie Coleman gave report of the Patriots Event in April, regarding testing canisters for life wests. About 40 members attended and only 3 had difficulties and needed help. Cheryl asked Julie if she possible could give the report at the general meeting May 9th.
