Secretary's Report:

- 1. April board meeting minutes were posted prior to the meeting
 - a. Motion to approve minutes by John with 2nd by Mary Lou passed unanimously.
- 2. Race results reporting update
 - a. Articles on recent races were composed by Dick and Laura and published in the Village News. Article on Homosassa Rodeo will be published soon.

Treasurer's Report:

- 1. April financial report was presented by Steve Augustine
 - a. Current member count is 372
 - b. Motion to approve report by Linda with 2nd by Dave passed unanimously.

President's Report:

- 1. Two compliance issues were reported and properly addressed by Cheryl
- 2. Design plans for improved Sumter Landing launch area are moving forward
- 3. Embracing the Youth
 - a. Recent combined Villages High School Band and Villages Band concert experience encouraged and inspired a future for youth dragon boating; potential for club growth

Vice-President's Report:

- 1. Hydrilla issues in the water are addressed by EPA schedule
 - a. Note that the water levels are low so the hydrilla appears to be worse than usual

- Avoiding sand in the bottom of the boats will minimize damage to the gel coat. Please ensure that boats are cleaned out properly and that paddlers are aware of sandy feet going into the boats
- 3. Dock box contents also need to be cared for; there should be nothing wet, including rags, in the boxes. Teams should not store rags or sponges used to clean boats in the dock boxes.
 - a. Beth and Linda will compose a memo to go out to the general membership for awareness

Boat Maintenance:

 - i. Susan will follow up with Lee on status of list
 - b. Gel coat repair estimate
 - i. Club vote was completed; repairs are approved to proceed
 - 1. 188 votes for completing repairs; 4 against
 - ii. Plan to execute repairs
 - 1. Scheduling an assessment of boats by Pan Am for a second quote
 - 2. This estimate will include transportation of boats for repairs
 - c. Boats in storage will be moved to a temporary storage location while maintenance occurs at the current storage location on May 22
 - d. Gunwale repairs have been completed on boats at Lake Sumter
 - e. Broken boat dolly at Lake Sumter
 - i. Village Dragons will fix broken PVC on the axle
- 2. Sale of 2014 BUK Boat
 - a. Possible buyer in Tampa that Cheryl is following up with
 - b. Captains please promote sale of this boat thru Facebook or other means
 - c. Steve and Laura will coordinate with potential buyers
- 3. Frame Repair status
 - a. Repair options report was previously sent out by Ken Loomis
 - b. Per Ken, Dick said that Warriors would build a frame for the 10-person boat
 - i. Motion by Laura, with second by Linda, that the club move forward with the Warriors building a frame for the 10-person boat was unanimously approved
 - c. Four remaining frames need to be built
 - i. Will reach out to general club membership at the General Meeting and via email for volunteers. Beth, Linda and Laura will coordinate this effort.

 - a. The Villages decision on taking this boat is pending
