- iii. Turtle Wax product will both wash and wax the hull
- d. PLEASE ensure that the boats and lockers are secure; multiple reports over the past few months that open locks are found
 - Captains should assign ONE individual to ensure area is secure after each practice
 - ii. Boats and storage bins must be secured
 - iii. ALSO check all boats at each practice to ensure they are covered and not holding water
